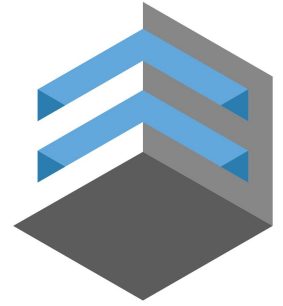

appearance

*synonym* : ordinary, unappealing, ugly

(1) **homely** environment, (2) plain **homely** furniture

We sold **homely** fruits and vegetables at a discount.
